EXECUTIVE SUMMARY

- The plan for a conference center on a 500-year old cemetery, with over 50,000 graves has been scrapped.
- The future of the Jewish cemetery is at stake.
- Lithuanian authorities are considering various options.
- The Save Vilna restoration proposal provides for collaboration between different Jewish Communities, within the parameters of Jewish law and culture.





GATE AND ENTRANCE

SCOPE OF RESTORATION:

- Sports Palace Facelift
- Restoration of tombstones, identifying existing graves according to the Klausner map
- THE IMPLEMENTATION OF THESE PROPOSALS IS SUBJECT TO THE APPROVAL OF AN AUTHORIZED AND RECOGNIZED RABBINICAL AUTHORITY.
- REMOVAL OF THE EXISTING BUILDING, REQUIRES THAT THE MINISTER OF CULTURE CANCEL THE PROTECTED LANDMARK STATUS OF THE ROOF AND BUILDING.




SPORTS PALACE FACELIFT





FEATURES:

- Preservation and restoration of graves, respect for deceased are primary goals.
- Facelift to external facade of defunct Sports Palace.
- All weather, educational exhibit boards (external to Sports Palace).
- Educational experience on history of Vilnius Jewish community and Holocaust.
- Daily tours detailing the history of Snipiskes.
- Majestic Gate at entrance.
- New restroom facilities (off original cemetery site)





FEATURES:

- LED flickering flame effect, mounted on restored tombstones.
- External lighting for educational exhibits and walkways.

VISUALS

The facelift proposal provides for restoration of the cemetery and a facelift to the the existing Sports Palace building.

The unique design of the roof, exhibiting brutal Russian architecture is retained.



PROPOSED MEMORIAL

- Sports Palace building, to serve as Monument for 230,000 Jewish lives that were martyred in Lithuanian Holocaust.
- Listing of Jewish lives, lost during World War II.
- Sports Palace building not be used for any other purpose, in compliance with Jewish law and recognition of memorial status.


"According to Jewish law, a cemetery can only be used as a resting place for the deceased. Using the area for any other purpose is prohibited."


