**The Government of the Republic of Lithuania
Resolution**

**ON THE RECOGNITION AND APPLICATION OF THE VILNIUS CONCERT
AND SPORTS HALL TO CONGRESSES, CONFERENCES AND CULTURAL
EVENTS AS A PROJECT OF NATIONAL IMPORTANCE**

Pursuant to Item 7 of Paragraph 2 of Article 4 and Paragraph 3 of Article 9 of the Law on the Centrally Managed State Property Manager of the Republic of Lithuania, the Description of the Procedure for Recognizing Projects as Projects Important to the State approved by the Government of the Republic of Lithuania in 2008. February 13 by resolution no. 136 “On Approval of the Description of the Procedure for Recognition of Projects as Projects Important to the State”, Item 4, Description of the Procedure for Centralized Management, Use, Disposal and Acquisition of New State Real Estate for Administrative Purposes, approved by the Government of the Republic of Lithuania in 2015. February 11 by resolution no. 148 “On the Implementation of the Centralized Management of State Real Estate”, item 50 and taking into account the Lithuanian Tourism Development Program for 2014–2020, approved by the Government of the Republic of Lithuania in 2014. March 12 by resolution no. 238 “On the Approval of the Lithuanian Tourism Development Program for 2014–2020”, the aim is to develop the tourism infrastructure and improve the quality of services, the Government of the Republic of Lithuania:

1. To recognize the project of reconstruction and adaptation of Vilnius Concert and Sports Hall for congresses, conferences and cultural events (hereinafter - Vilnius Congress Center project) as a state important project, the aim of which is to establish a new congress, conference and cultural events center, promote and develop tourism in order to increase Lithuania's awareness and competitiveness of the tourism sector and to create conditions for attracting investments, taking into account the results of the Vilnius Congress Center project and their indicators, implementation deadlines and measures specified in the Annex to this Resolution.

2. Assign:

2.1. for the manager of centrally managed state property - the state enterprise Turto bankas (hereinafter - the appointed executor):

2.1.1. to implement the project of the Vilnius Congress Center, the planned value of which is up to LTL 29 million. (twenty-nine million) euros, including value added tax;

2.1.2. implementing the Vilnius Congress Center project, to acquire the state-owned Vilnius Concert and Sports Palace building complex in Vilnius, Rinktinės str. 1 (building - congress center, unique number - 1097-3019-3016; administrative building, unique number - 1097-3019-3020; other engineering structures - courtyard buildings with unique number - 1097-3019-3052), required for Vilnius to implement the project of the Congress Center, and to sign the purchase agreement (s) for the Vilnius Concert and Sports Palace building complex;

2.2. The Ministry of Finance of the Republic of Lithuania, on behalf of the State of the Republic of Lithuania, to compile with the designated executor the Description of the Procedure for Recognition of Projects as Projects Important to the State. February 13 by resolution no. 136, the contract specified in Item 8, in which the appointed executor would undertake to implement the project of the Vilnius Congress Center within the set time and to the extent;

2.3. Institutions subordinate to the Government of the Republic of Lithuania - to examine, in order of priority, documents related to the implementation of the Vilnius Congress Center project and to ensure the adoption of decisions related to this project within the shortest possible time.

3. To establish that the appointed executor implements the project of the Vilnius Congress Center:

3.1. using the funds of the state budget and state resource funds, own funds;

3.2. in order to attract private partners for congresses, conferences and cultural events to be leased through a public lease tender.

4. Propose:

4.1. other state and Vilnius city municipal institutions, enterprises, institutions and organizations shall follow Sub-paragraph 2.3 of this Resolution when examining documents related to the implementation of the Vilnius Congress Center project and making decisions related to this project;

4.2. Vilnius City Municipality, which participates in the implementation of the project of arrangement of the territory of the Jewish Šnipiškės old cemetery and perpetuation of this cemetery, if necessary, to coordinate the necessary decisions with the appointed executor.
